The Board of Trustees held their regular meeting on Wednesday, March 9, 2016 in the School Library at 7:00 p.m. as posted. Those in attendance were Chairman Cecil Martin, Vice-chairman Bryce Scrimsher, Trustees Kathryn Bomar, Dustin Heinzerling and Eric Steigers, Superintendent Alan Felgenhauer, Principal Chase Woodford, Clerk/Treasurer Loretta Hammond-Nichols and two staff members.

CALL TO ORDER/SALUTE

Chairman Martin called the meeting to order at 7:05 p.m. and those present joined in the flag salute.

SUPERINTENDENT REPORT

*BUDGET STATUS (2/29/16) – Budget looks good with the projected revenue up and the expenses not over budget. The District should be looking at a carryover for next year. A thank you to the PTSA for getting the word out to vote on the two year levy. The patrons passed the levy at a higher percentage than the last election.

*LEGISLATIVE UPDATE –JFAC approved a 6.8% increase for education funding. Most of that is to cover the increase costs of the career ladder and the increase of the discretionary unit funding. The legislature is discussing trustee zone elections which would allow all patrons to vote for the positions versus just the residents within that trustee zone.

*BUILDING UPDATE – the upstairs girls' restroom remodel has been completed. The HVAC equipment has been ordered with the install planned for this summer after the new fiscal year starts.

*SCIENCE TEACHER – Ms. Washburn received a STEM Grant of \$1,000.00 for the Robotics Club. She plans to purchase a laptop that will be able to program the robots. The students build the robotics and then learn to program them.

PRINCIPAL REPORT

- *ENROLLMENT- Preschool 5th grade is 41 students, Junior High is at 27 students, and High School is 21 students for a total of 89 enrolled.
- *STUDENTS OF THE MONTH-elementary is William England and secondary is Mackenzie Darnell.
- *EVENTS/ACTIVITIES K-8 grades Spelling Bee competition winner is Joss Reid. He will compete at the Regional in Lewiston. Second place went to Jacquelin Stroud and third place to Lance Sanford.

Robotics team was not able to finish the competition in Moscow since the current laptop failed to work the robot. Robotics Advisor, Ms. Washburn, is excited for the STEM Grant to purchase a new laptop that will be able to run the robot.

BOARD COMMENTS

Chairman Martin commented that the goals meeting at the Red Lion in Lewiston went well with the staff and students. He wanted to extend a thank you to them for their participation.

Principal Woodford thought the goals meeting was a great process.

Trustee Bryce Scrimsher thanked everyone for their support in passing the two-year supplemental levy.

The final quotes which include the delivery of the bus to Culdesac School without a trade-in is:

The recommendation is for the Western Mountain Bus Sales bus bid at the \$82,309.00 quote.

The Seventh and Eighth grade for Junior High next year. Currently the Sixth to Eighth grade is Junior High. Mr. Tiegs has giving his resignation for next school year which gives us a 1.0 FTE for an elementary position.

Principal recommends that the sixth grade students receive more individual teacher help before they join the Junior High and High School students.
