SUPERINTENDENT REPORT

BUDGET STATUS (1/31/17)

Superintendent commented that the budget is doing well. The Food Service Program is now showing a balance and will reimburse the district for food and supply expenses. The proposed budgets for next fiscal year by the Idaho Superintendent of Education and the State Governor was given to the Board for their review.
